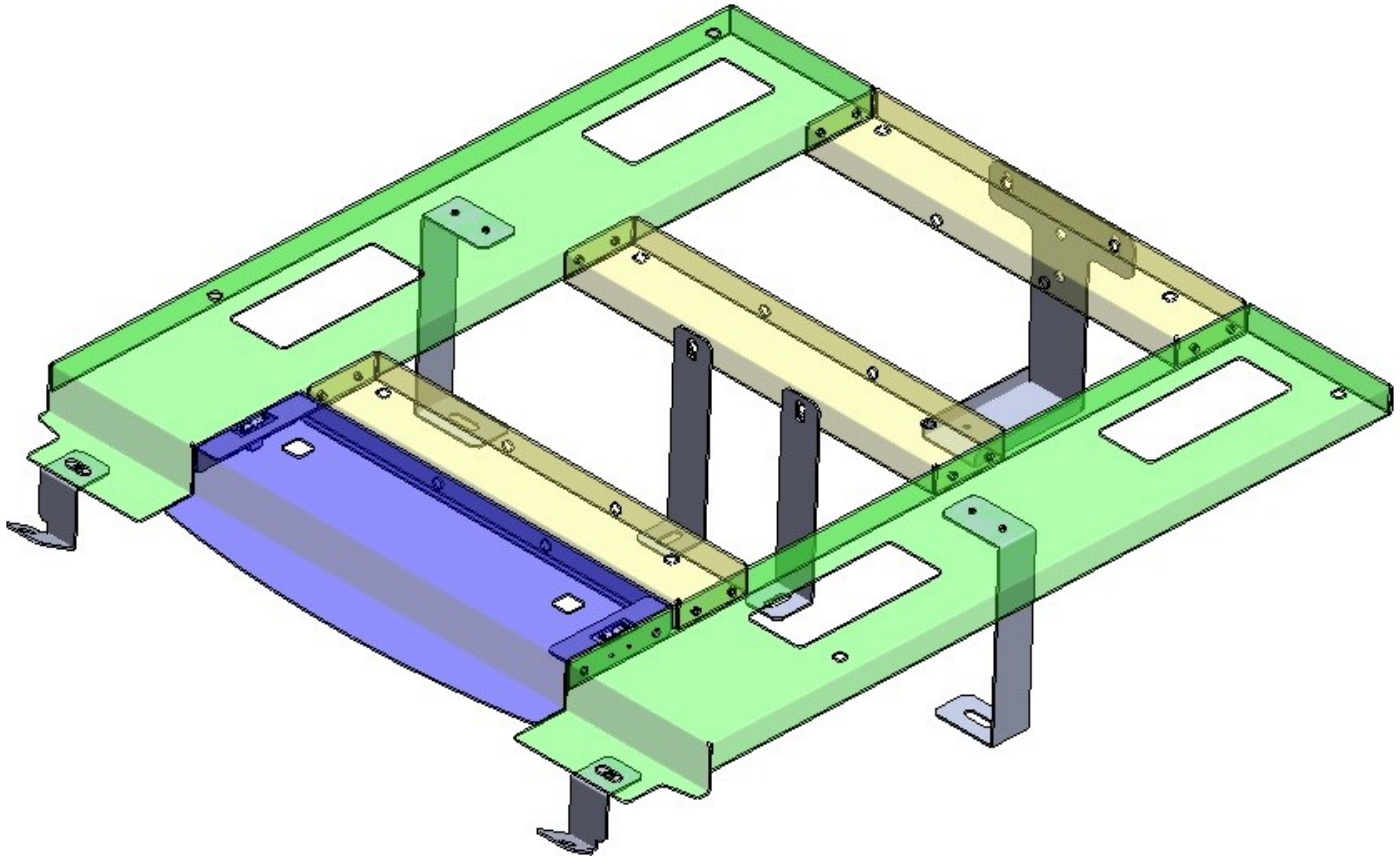

UNPACKING

Before beginning any installation, unpack the equipment received. Upon unpacking, examine **ALL** components received for any damage that may have occurred while in transit. If any damage has occurred, file a claim **IMMEDIATELY** with the courier stating the extent of damage. Check **ALL** envelopes, packing slips, shipping labels and tags before removing or destroying them. To ensure your satisfaction, open all cartons and report any shortages **within 48 hours of receipt.**

INSTALLATION

Step 1

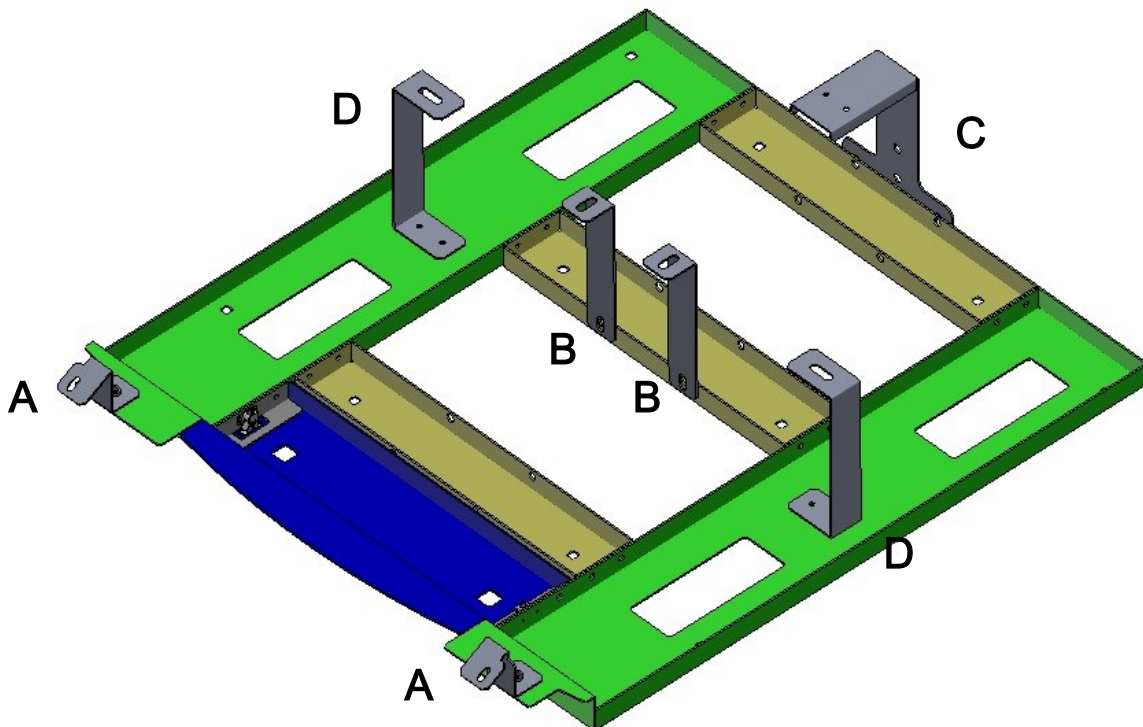
Vehicle Preparation

Remove the 3rd Row seating (if present). Remove all plastic panels from the area where the sub frame is to be placed.

Step 2

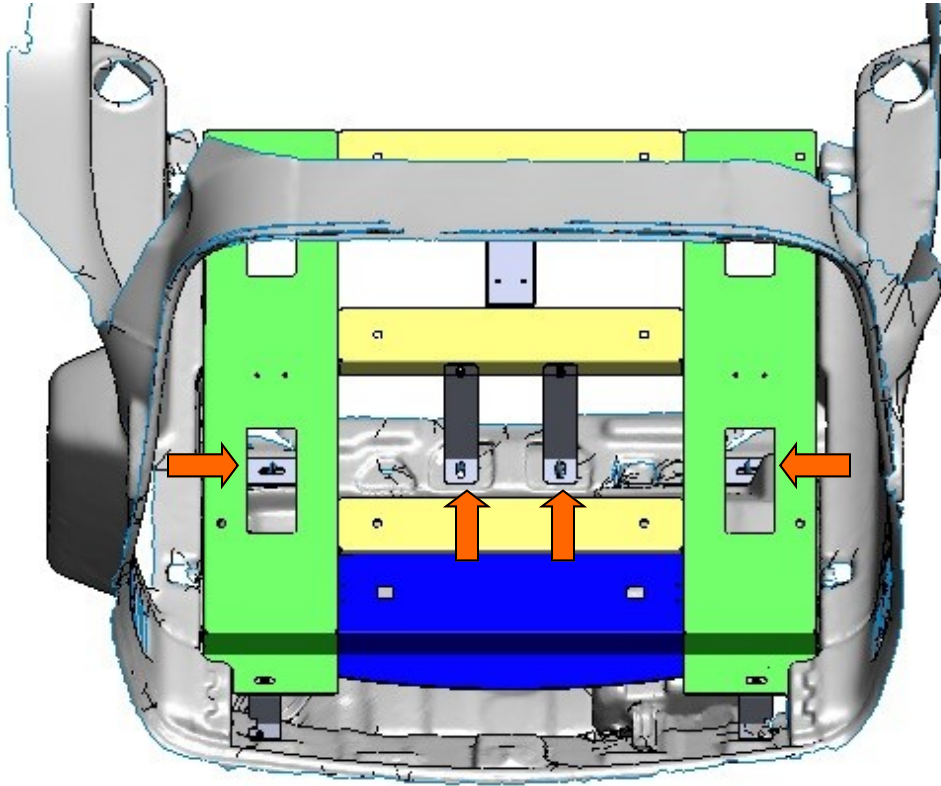
Frame Preparation

1. Place sub frame upside down as shown below.
2. Place the Front Mount Brackets DS & PS (Marked A) and secure using 2X Hardware Line 1,2 & 3. **Do not Tighten.**
3. Place the Rear Mount Brackets (Marked B) and secure using 2X Hardware Line 1, 2 & 3. **Do not Tighten.**
4. Place the Rear Mid Bracket (Marked C) and secure using 2X Hardware Line 1, 2 & 3. **Do not Tighten.**
5. Place the Side Brackets (Marked D) and secure using 4X Hardware Line 4 & 5.



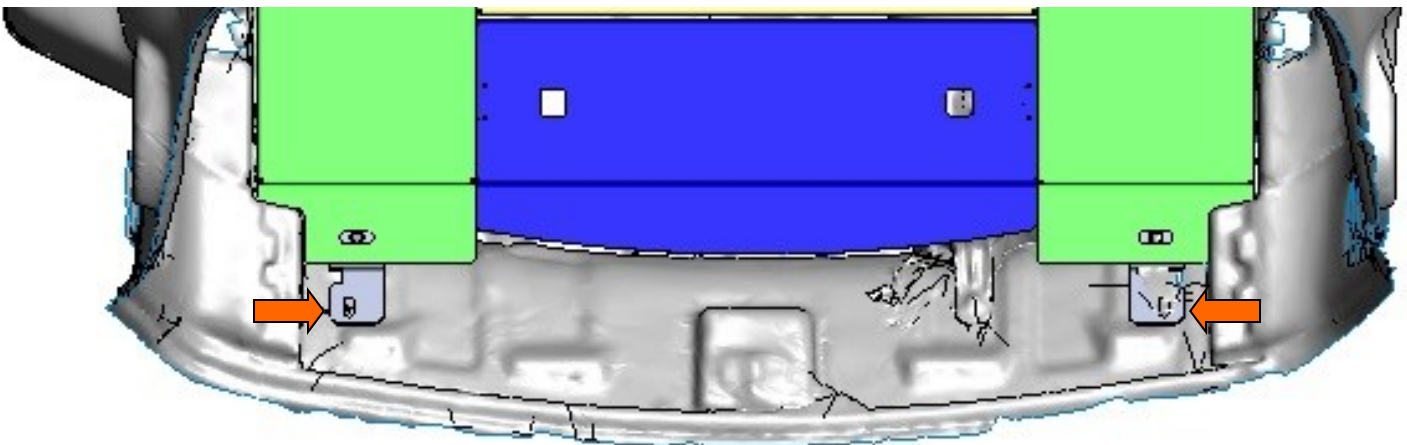
Step 3 Frame into Vehicle

1. Open the lift gate and carefully place the sub frame over the 3rd row seat Bolts and secure sub frame using Hardware Line# 7.



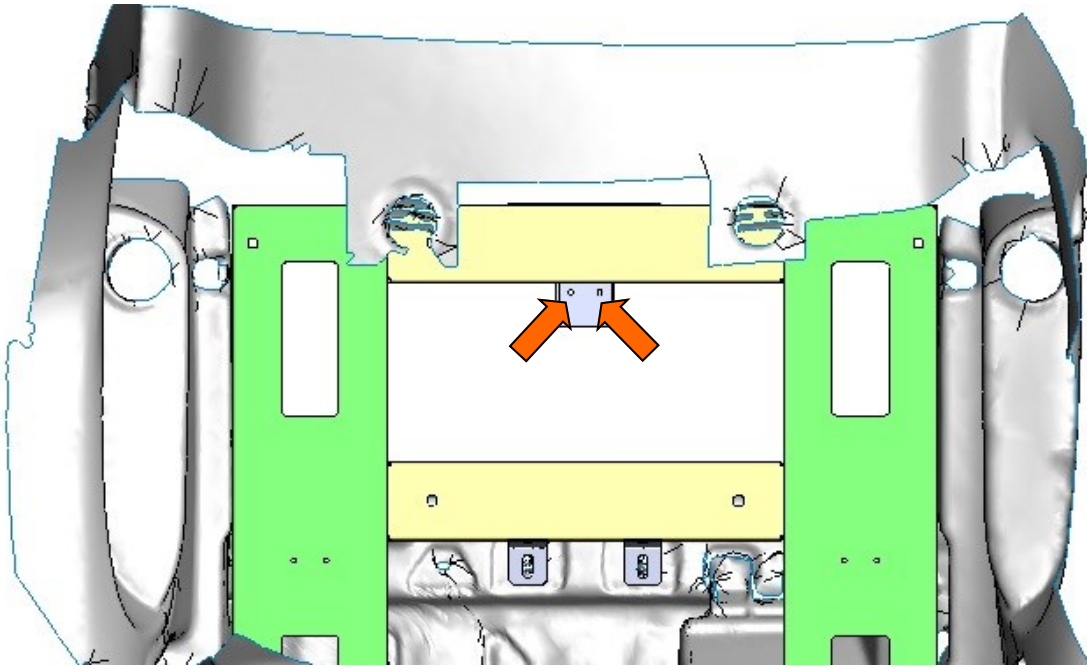
An overall view of the sub frame, looking in from the rear of the vehicle.

2. Secure Sub frame front mount brackets to vehicle using factory nut and stud present on vehicle.



3. Tighten all Nuts and Bolts that were left loose until now.

4. Using Hardware Line 6, Secure the Rear End of the Sub frame.

PRODUCT RETURN POLICY
