Installation Instructions:

Step 1

Remove loose trunk contents, also remove the jack front the rear DS panel and place inside storage unit. Remove center seat rear nuts (4 places) keep as side for installing sub frame mounting brackets.

NOTE: That there is a fuse panel DS rear which will not be accessible once a cabinet is install and the cabinet will have to be removed to access any blown fuses in the location.




Flip up Rear Seats to access 4 nuts.

Step 3




Place up right sub frame into place and fasten respective bolts into place. Use supplied M8 x 1.25 x 25mm Long/ Lock Washer / Flat Washer to secure subframe near the tailgate to floor.



Step 4

Place sub frame rear brackets over factory seat studs. Secure with the four nuts removed. Using supplied 1/4-20 hex bolt/ Flat Washer/ Lock Washer (8 sets) hardware secure brackets to the back of the sub frame.

Ensure all Hardware is tightened. and Proceed to install Top Storage Unit.
