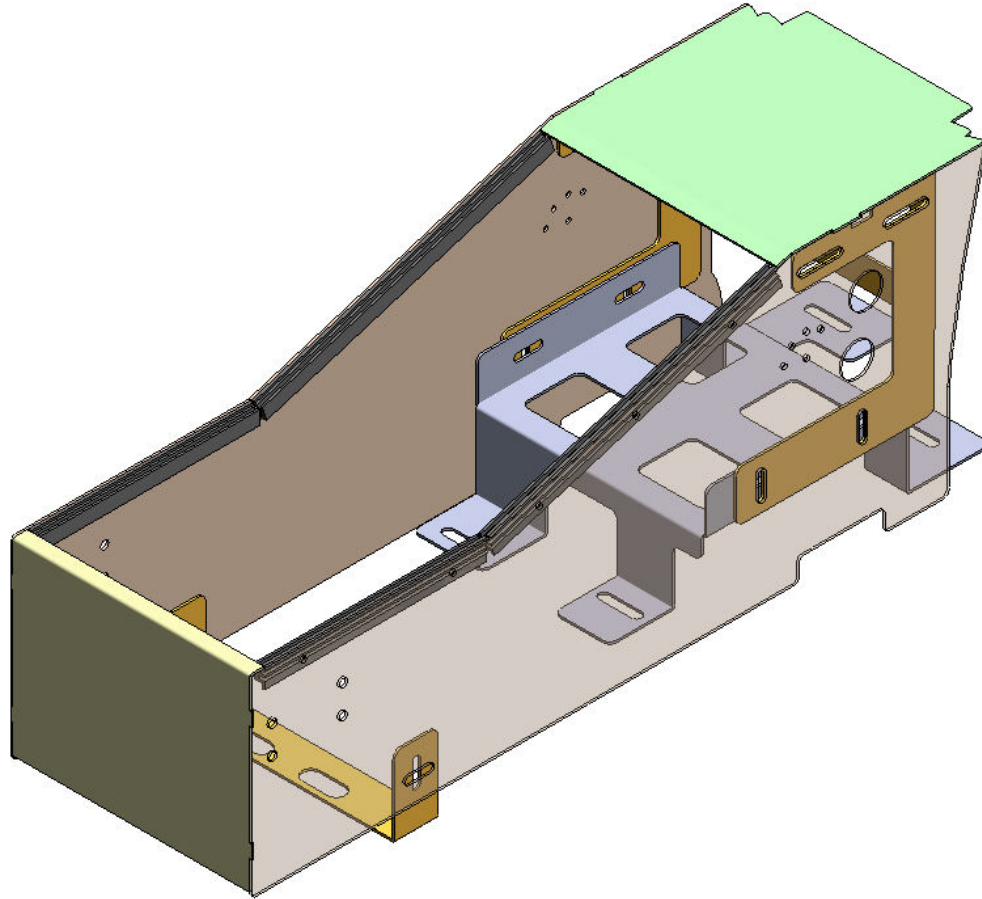

Installation Instructions

Step 1
Remove the factory side panels and then remove lower dash section by loosening 2 Screws on either side.



Step 2

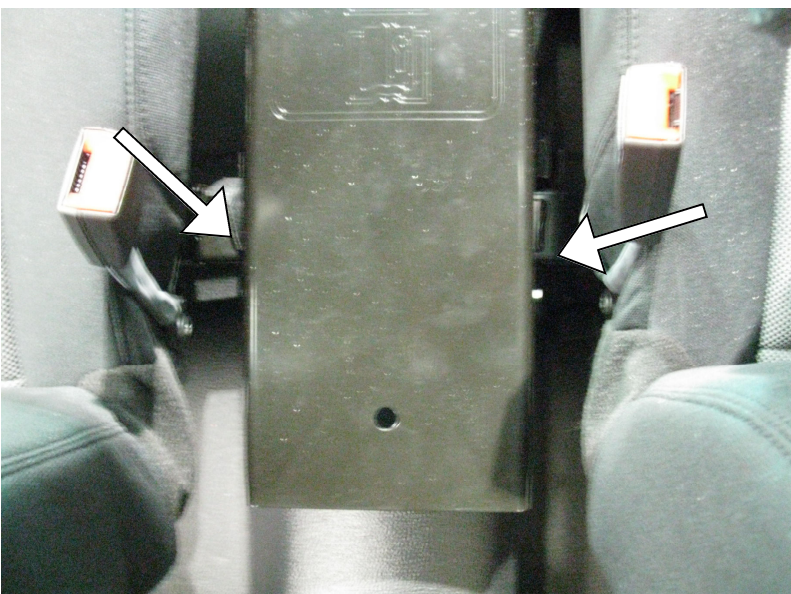
Remove 2x (12v) sockets from removed dash panel and re-install on the passenger side of the new console. Note that the metal part of the socket has been separated for easy install.



CAUTION: DO NOT hammer or force the plastic covers. They have a pin on each side, that must be pressed using a small flat-head screwdriver when installing.

Step 3

Remove Console Area Factory Floor Plate by removing 2 bolts located under the dash, 2 inside the cutouts on top of the plate and 2 bolts on the back side of the plate. Retain hardware for new console.



Step 4

Attach lower dash part back in. Run the harness and 2x (12v) sockets connectors through. Bolt this back in place with the 2 bolts removed from step 2.



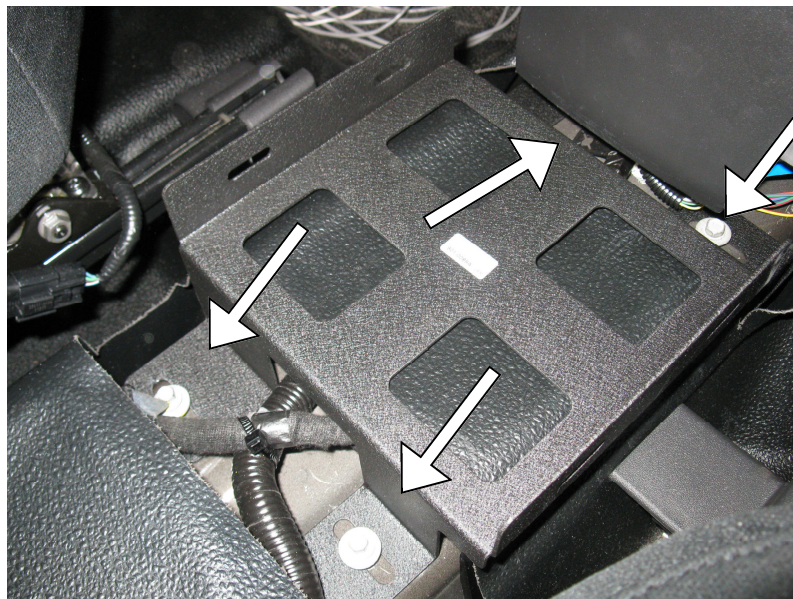
Step 5

Lift the Carpet located between the front seat belt locks. Remove the 2 nuts on the floor, and mount the rear console bracket. Center bracket and tighten nuts.



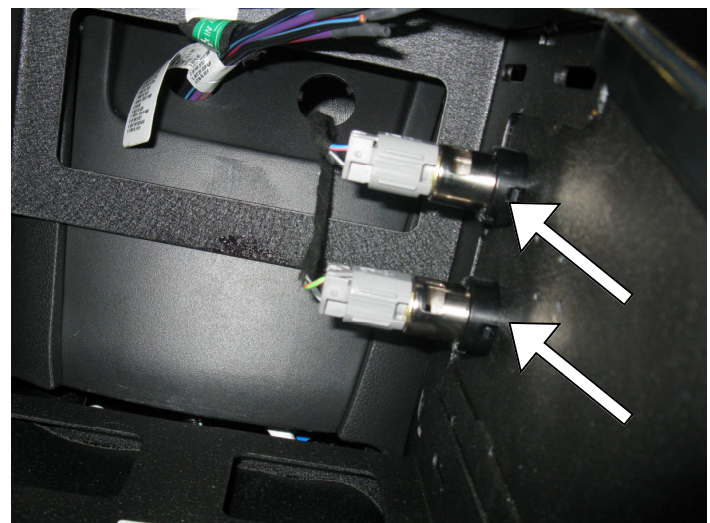
Step 6

Mount the front console bracket using bolts removed in Step 3. Using the console as reference, center the bracket and tighten the bolts.



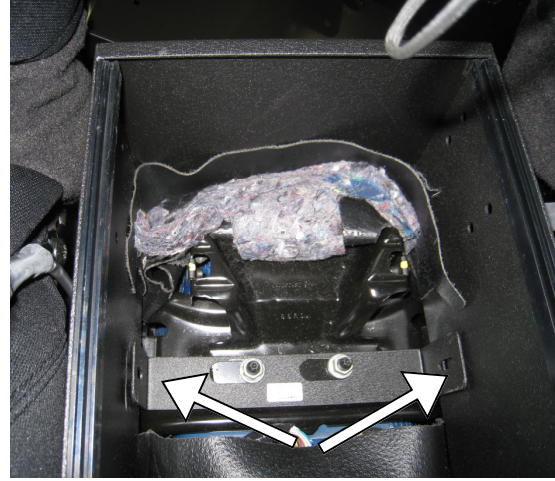
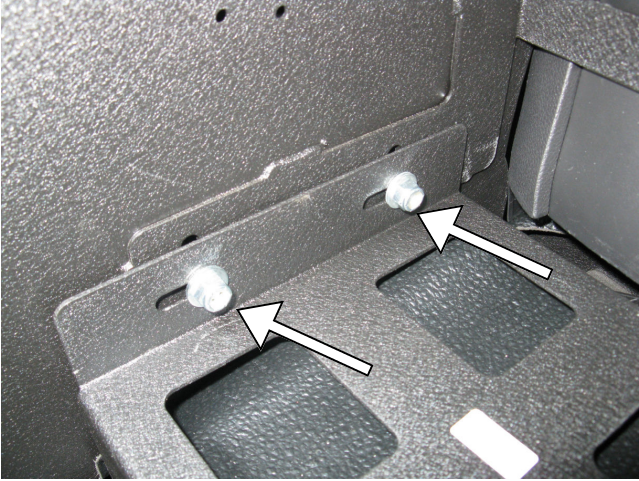
Step 7

Attached dash side panels and place console on mounting brackets, connect the 12v sockets.



Step 8

Attach console to both, front and back, mounting brackets using supplied hardware.



Step 9

Slide console forward tight to dash and tighten the 4 front bolt and the 2 rear bolts.
