

## UNPACKING

Before beginning any installation, unpack the equipment received. After unpacking, examine **ALL** components received for any damage that may have occurred while in transit. If any damage has occurred, file a claim **IMMEDIATELY** with the courier stating the extent of damage. Check **ALL** envelopes, packing slips, shipping labels and tags before removing or destroying them.

To ensure your satisfaction, open all cartons and report any shortages **within 48 hours of receipt.**



## VEHICLE PREPARATION

Removal of front passenger seat is required to install the floor mount.


## INSTALLATION OF FLOOR PLATE

After removing the seat, align the slots on the floor mount to the hooks on the underside of the seat rails. Install the seat back in place along with the floor mount.




Follow the drawing on the next page for securing the brackets to the floor mount.
