

### UNPACKING

Before beginning any installation, unpack the equipment received. After unpacking, examine **ALL** components received for any damage that may have occurred while in transit. If any damage has occurred, file a claim **IMMEDIATELY** with the courier stating the extent of damage. Check **ALL** envelopes, packing slips, shipping labels and tags before removing or destroying them.

To ensure your satisfaction, open all cartons and report any shortages <u>within 48 hours</u> <u>of receipt.</u>


### VEHICLE PREPARATION

# INSTALLATION OF STORAGE UNIT Step 1

## **Remove Cabinet Top**


Remove all the Bolts located on the top of the cabinet and carefully lift the cabinet top and place aside.




## Step 2

## **Check Mounting location points**

Carefully open and if possible remove the drawers, top whiteboard sliding tray and base above bottom drawer. Measure and evaluate the mounting locations of the cabi-






**Step 3 Place Retainer Nuts on Sub frame** 

Place Retainer Nuts on Sub frame based on the mounting locations found in Step 2..




# **Step 4 Place Cabinet on Subframe**


Carefully place Cabinet on Sub frame and Secure using 3/8 X 1" Hex Bolts, 3/8" Lock Washers and 3/8" Washers on locations found in Step 2.



Step 5 Close/Replace the drawers, top whiteboard sliding tray and base plate above bottom drawer.



**Step 6**Replace the Cabinet Top, replace front four bolts and washers removed in Step 1.



## **Installation is now Complete**

### **WARRANTY**

This warranty is in lieu of all other express warranties. D&R Electronics makes no warranties, expressed or implied, other than the express warranties contained herein.
