## **Unpacking**

Before beginning any installation, unpack the equipment received. After unpacking, examine **ALL** components received for any damage that may have occurred while in transit. If any damage has occurred, file a claim **IM-MEDIATELY** with the courier stating the extent of damage. Check **ALL** envelopes, packing slips, shipping labels and tags before removing or destroying them. To ensure your satisfaction, open all cartons and report any shortages **within 48 hours of receipt.**

# **General Warning**

- 5. The device must be installed so as not to reduce the output performance of vehicle systems.
- 6. Placement of control switches must be so as to provide convenient reach for the operator while maintaining eye contact with the road.
- 7. Emergency warning devices require high electrical voltages and/or currents. Properly connect and ground all circuits. Shorting or improper grounding of this device may cause personal injury, vehicle damage or both.
- 8. All operators should be properly trained in the operation of this device to ensure both their and public safety.

## Installation and Mounting

## Warning

- Any device used inside a vehicle may cause severe personal injury if not properly mounted and secured.
   Objects used in the vehicle may become airborne during a collision or other sudden changes in vehicle speed or direction, such as breaking acceleration or turning.
- 2. Be sure to mount unit through the steel of the vehicle. Avoid mounting through plastic or other non-structural materials.
- 3. POINT OF INSTALLATION MUST NOT INTERFERE WITH DEPLOYMENT OF VEHICLE AIRBAGS
- 4. D&R Electronics recommends tis or any of our products be installed by qualified professionals.



#### **Electrical Connections**

- 1. Plug the 215-0374-PG1 cable connector into the 215-0374-20 cable connector.
- 2. The open wires from the 215-0374-20 cable are to be wired into the control box as shown in Figure 2.
- 3. Wire the 215-0039 cable to the control box as shown in Figure 2.
- 4. Plug the 215-0038-M cable connector into that of the 215-0039 cable.
- 5. Plug the touchpad connector into the Mini-Fit connector on the 215-0038-M cable.
- 6. Wire the remaining 215-0038-M wires as shown in Figure 2.

## **Operation**

After the system is assembled, the traffic director may be operated and controlled by the AS5500 touchpad. The buttons on the touchpad correspond to flash pattern functions on the traffic director stick. For example, the "LEFT" button activates the left arrow flash pattern.




## **Mechanical installation**

## Mounting through channel

Two sets of mounting brackets with bolts, nuts and washers have been supplied with this unit, and can be found in the parts box. Unless otherwise mentioned, the custom mounting hardware referenced has also been supplied with the unit.

Out of the two brackets provided, one bracket is shown in Fig 3 below. As shown, the shorter leg of the bracket is to be fastened to the deck with the provided hardware. Two carriage bolts must be slid into the LED Traffic Director back channel and then inserted into the oblong slots on the longer leg of the mounting bracket. The slots are oblong in shape to give you maximum flexibility in securing the most convenient position required for the unit.



## **Installation of AS5500 Touchpad Bracket**

Mounting bracket for touchpad is supplied with the package.

With supplied screw and washer fit the touchpad with the one side of bracket as shown in figure 5 below, Secure the other bracket on deck or desired location and attach both brackets as they were before as shown.



Connect the routed cable from traffic director control box to the touch pad.

#### Maintenance

The Genesis Traffic Director has been designed to provide trouble-free service and minimum routine maintenance. Occasional cleaning of the Traffic Director lens is all that is required to produce maximum light output. Cleaning should be done with a soft cloth to avoid scratching of the lens. The lens should not be removed at any time. If problems are encountered and are unresolvable, contact D&R Electronics for further advice.

# Warning
