

UNPACKING


VEHICLE PREPARATION:

Remove the third row seating and set aside. The removed bolts will be used to fasten the sub-frame. If there was no third row seating, bolts are supplied for mounting. Remove loose truck contents.

Installation Instructions:

Step 1:

Using the indicated mounting points in Figure 1.0. Attach the three Front Mounting Legs to the vehicle using M10 x 1.5 Hex Bolt (x3), M10 Lock Washer (x3) and M10 Flat Washer (x3). Ensure the components are square with the vehicle.



Note: The factory carpeting might have to be trimmed to accommodate the Front Mounting Legs.

Step 2:





Figure 1.2: Front Leg Mounting Points

Using the indicated mounting points in Figure 1.2 with the number "2". Attach the two Middle Supports to the vehicle using M10 x 1.5 Hex Bolt (x2), M10 Lock Washer (x2) and M10 Flat Washer (x2). Ensure the components are square with the vehicle.



Step 3:

Using the indicated mounting points in Figure 1.2 with the number "3". Attach the Center Mounting Bracket to the vehicle using M10 x 1.5 Hex Bolt (x3), M10 Lock Washer (x3) and M10 Flat Washer (x3).




Step 4:

Carefully place the assembled Subframe Main Body onto the Front Mounting Feet, the Middle Support Feet and the Center Support Bracket that were previously installed. The curved edge should be facing the rear of the vehicle.



Step 4:

Fasten the Subframe Main Body to the Feet and the center bracket using $1/4-20 \times 3/4$ " Hex Bolt (x11), 1/4-20 Flat Washer (x11), 1/4-20 Lock Washer (x11) in the indicated mounting points in Figure 1.7 and Figure 1.8.





Ensure all hardware is tight and secure. Installation is now complete.
