Move passenger seat back as far as it can go. Loosen plastic caps covering front seat bolts.





Step 4 Install LT6600 mount to base.

Install console brace with 2x 1/4-20x 5/8in carriage bolts with flat washers to attached.

Install dash brace with 1/4-20x 5/8in carriage bolts with flat washers use factory trim bolt to attached under the dash.
